8. Describe your institution's most successful strategies in meeting the assurances listed above:

Furman University's teacher preparation program responds to the identified needs of local/state schools where program completers are likely to teach as demonstrated through continued hiring rates averaging 100%. Through strong partner school relationships, Furman's program links the needs of schools and the instructional decisions new teachers face in the classroom through a focus on impact on student learning and candidate use of technology for student learning, and areas of greatest need for teaching effectiveness as identified through employer, alumni, and school mentor feedback. Through special partnerships with local school districts, elementary candidates obtain induction year positions with an "internship certificate" as part of our extended program to meet teacher vacancy needs. These special district partnerships also allow Furman to place music and MAT candidates in high-quality classroom settings for a more traditional student teaching internship. Furman works closely with the South Carolina State

Department of Education's Office of Educator Services in preparing prospective and novice teachers to meet Expanded ADEPT standards. Furman also works with external partners to provide professional development coursework/endorsements/credentials to meet district-level needs for training teachers in ESOL, as well as training for cooperating teachers and candidates on the South Carolina Teaching Standards 4.0 model of mentoring and evaluation. Candidates are placed in a variety of settings, including urban, rural, and Title I designated schools, whereby a high number of students are in the free and reduced lunch program. Undergraduate and MAT candidates take "Students with Exceptionalities" to acquire and practice strategies for teaching students with special needs. All candidates learn and practice general instructional strategies through required methods courses. Specifically, elementary certifiers are required to take "Literacy Foundations and Instruction in Grades PK-3" and "Literacy Processes and Instruction in Grades 2-6." During the senior practicum, elementary certifiers also take "Content Literacy Strategies and Modifications for Diverse Learners." MAT secondary and foreign language candidates complete a practicum and methods courses that provide candidates with the opportunity to understand, acquire, and practice instructional strategies for teaching students from a wide range of socio-economic and demographic backgrounds, including students with limited English proficiency. The 2017 ISTE Standards for Educators frame the use of technology in Furman's Teacher Education Program, with emphases on teacher as designer, facilitator, analyst, and collaborator. In upper-level methods courses, elementary candidates, for example, learn how to use technology to teach specific subject matter. In "Literacy Foundations and Instruction in Grades PK-3", candidates create an online read aloud to share with 2nd grade students. In "Literacy Processes and Instruction in Grades 2-6", they use video creation tools to construct a digital book trailer for a recently published children's book. Elementary candidates also utilize communication software such as Zoom or Microsoft Teams to enhance instruction and connect American classrooms to various international settings. During an extended practicum that occurs during the spring of the senior year for the elementary program and fall for the secondary MAT program, candidates explore a variety of technologies (e.g. Padlet, Flipgrid, Canva, Kahoot, etc.) for instruction as well as data collection. Candidates in both programs develop a technology portfolio as evidence of the implementation of activities aligned to the ISTE Standards for Educators. Candidates also teach a unit work sample in their classrooms in which technology is a significant component and a point of evaluation in a performance rubric. Candidates quickly become comfortable with and adept at using a wide range of supplementary tools, including Chromebooks, interactive white boards, science probes, and mobile technologies. In the internship, both elementary and MAT candidates are also evaluated on their use of technology to collaborate with colleague and students, design authentic learning environments, facilitate student achievement, and understand and use data to drive their instruction.

#### a. Teach students with disabilities effectively

All teacher candidates are required to complete successfully an introductory-level course (“Students with Exceptionalities”) covering information about various types of disabilities and legislation governing educational services for students with disabilities. Furthermore, this course exposes teacher candidates to many types of various learners, including students who are at-risk for specific learning difficulties due to environmental and biological factors. Teacher candidates are provided with information, videos, activities, and technology regarding services for students with identified disabilities. Candidates are also provided with opportunities to acquire and practice instructional strategies for students with limited English proficiency, and students who are from various cultures, with and without disabilities.

#### b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

An important component of the Students with Exceptionalities course includes a required, associated field experience in which all teacher candidates receive a minimum of 20 hours of school experiences working with students identified with disabilities who are receiving special educational services and/or with students who may be considered at-risk for learning problems. The field experiences allow teacher candidates an opportunity to interact with students with disabilities in the full continuum of placements. This course addresses a variety of foundational content, as well as exposure to collaborative teaching models (including team roles for individualized education plans). Even though this is not a pedagogy course per se, candidates receive some enrichment activities in and out of class related to instructional strategies, meeting IEP goals, and may be invited to sit in on IEP meetings as a guest observer, during field work.

#### c. Effectively teach students who are limited English proficient.

During the senior year practicum experience, all teacher candidates are required to complete successfully a course titled “Content Literacy Strategies and Modifications for Diverse Learners” focused on strategies that facilitate reading and writing in the content areas and appropriate methodology for working with Multilingual Learners (MLs). Designed for preservice candidates enrolled in the senior practicum and music education internship candidates, this course introduces strategies and practices that facilitate language and content learning across cultural, ethnic, and language diversity. Educational, cultural, and linguistic considerations for modifying instruction of diverse learners are examined and applied in candidates’ respective practicum and internship placements during the senior year. Specifically, teacher candidates learn and apply Second Language Acquisition (SLA) principles to instructional planning. SLA pedagogy for working effectively with MLs is studied and implemented in lesson design. The course also includes other important instructional components for content-area reading and modifications for diverse learners. Teacher candidates learn Before, During, and After (BDA) strategies that support reading comprehension in the content areas for learners in diverse contexts. They are provided with an opportunity to develop and present a BDA strategy in class and participate in peer and self-assessment in addition to receiving formal feedback from the course instructor. Candidates then implement one of these strategies in a lesson in their practicum placement. As part of the lesson, candidates are required to provide modifications for each of the five stages of language acquisition. Moreover, teacher candidates learn how to assess and use MLs’ Funds of Knowledge to survey and integrate home culture and language within the classroom and curriculum.

Music Education candidates complete licensure requirements in four years. Extended program candidates (undergraduate elementary education) complete a long-term practicum during the senior year and complete the student teaching internship following graduation during the fall of the fifth year. Extended program candidates may be hired as the teacher of record as part of an induction year position with partner school districts. Candidates receive the support of a university supervisor and district mentor during their induction year of teaching. Master of Arts in Teaching (MAT) program candidates complete secondary and languages content area licensure in one year. Coursework begins in summer terms and candidates complete a full-time practicum during fall semester and a full-time student internship during spring semester.
